Every industry has its own security requirements

Protection of personal data is gaining more and more attention. Whereas in the past it was the financial sector that was concerned about the data of cardholders, nowadays all sectors believe that the data of customers, citizens or patients must be handled carefully and securely. All sectors have therefore started working on this themselves, resulting in various security standards.

PCI DSS



GDPR



The PCI DSS standard is developed by the major credit card organisations. The goal is to enlarge the control on cardholder details and to decrease credit card fraud.

The vulnerability scan of Trust Guard is executed by a PCI Security Standard Council approved scanning vendor and will, together with the self assessment questionnaire (SAQ), determine if your business is PCI compliant for level 2, 3 and 4.

The GDPR determines how businesses should handle personal details, on a technical and organizational level. The regulations are mandatory since May 2018.

The Trust Guard scan checks if your website and/or network is secure. The report that you can make of this scan can be used to demonstrate that you do everything to comply with the GDPR.

ISO27001



OWASP



The ISO27001 standard contains multiple aspects regarding information security, among which system and software development and maintenance. Keeping the ISO27001 certificate is a continuous process.

Trust Guard helps to indicate security risks in compliance with this standard and offers possible solutions.

The mission of Open Web Application Security Project is to give an insight in the safety of specific software, so individuals and organizations can make a deliberate decision about their security.

The security scan of Trust Guard scans multiple vulnerabilities and can generate a report with the findings based on the OWASP Top 10.

SOX



HIPAA



The SOX-standard is derived from the US senators Paul Sarbanes and Michael Oxley bills. The act is particularly meant for large companies that manufacture and use their own software. The goal of the act is to prevent fraud.

The Trust Guard SOX-report offers insight in internal and external vulnerabilities.

The Health Insurance Portability and Accountability Act regulates privacy protection in the healthcare sector. Within the Act standards regarding information security are described, in which procedural, technical and physical security measurements are suggested.

With the Trust Guard scan vulnerabilities will be identified and suggestions will be made. Furthermore the HIPAA report offers support to demonstrate you did everything to protect the data.
